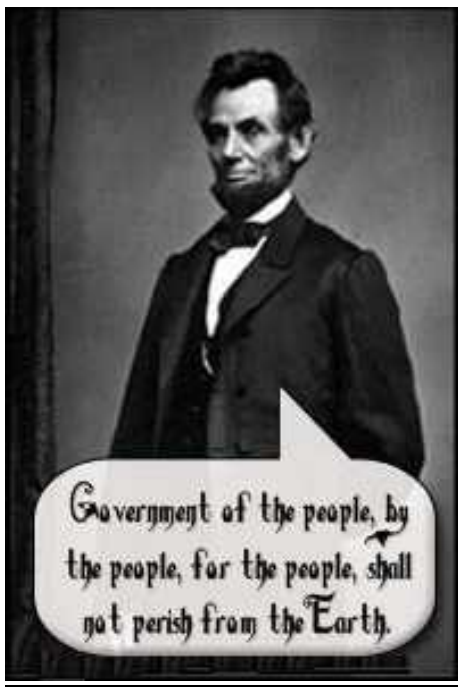

### CITY OF SAINT MARY ORDINANCE NO. 791

WATER CHARGES SHALL NOT BE ADJUSTED. DEFECTIVE METERS OR UNDETECTABLE LEAKS WILL ONLY BE ADJUSTED TO THE SEWER PORTION OF YOUR BILL NEVER THE WATER PORTION.

At the request of Appointed Mayor Carl Wyatt. Aldermen Bequette, Stokes and Bovey voted to stop Aldermen Gerardot from warning customers if their service is scheduled for disconnect.

For nine consecutive months Alderman Gerardot successfully ensured no services were disconnected.

The disconnect policy returned to no knock on your door, no notice left on your door and no information on how to have services restored.

If your service is disconnected more than 15 days, Aldermen Bequette, Stokes and Bovey voted to charge you a \$300 reconnection fee in a 3-1 vote.

(CSR 240-13) RULES OF ECONOMIC DEVELOPMENT DIVISION 240 PUBLIC SERVICE COMMISSION CHAPTER 13 MISSOURI CODE OF STATE REGULATIONS FOR SERVICE AND BILLING PRACTICES FOR RESIDENTIAL WATER AND SEWER UTILITIES.

THE PURPOSE OF THIS RULE IS TO ESTABLISH REASONABLE AND UNIFORM STANDARDS TO BE OBSERVED BY UTILITIES AND CUSTOMERS.

THE CITY OF SAINT MARY DOES NOT FOLLOW THE DISCONNECT RULE OR ADJUSTING WATER BILLS FOR FAULTY WATER METERS RULE.
