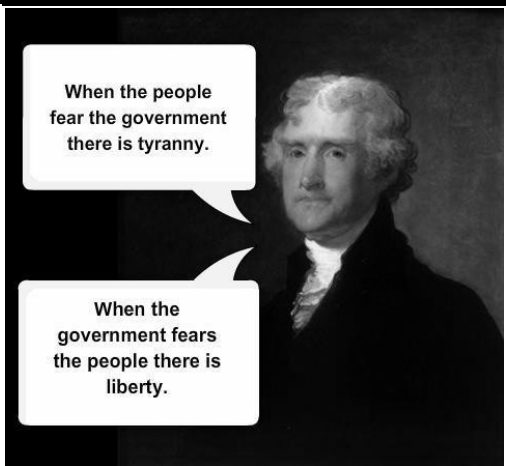

When Alderman Gerardot Questioned Alderman/Water Operator Bovey about the lack of timely notification, he said he was following the DNR guidelines for notification. Then he asked if the Veterans home had been notified by a phone call promptly as soon as it was reported by DNR. Bovey said no and Mayor Wyatt added that the Senior Apartments were not notified either. DNR said the city was following the bare minimum requirements. DNR stated to notify Marion Cliff Manor and the senior apartments is important but, it is not mandated for the city to do so.

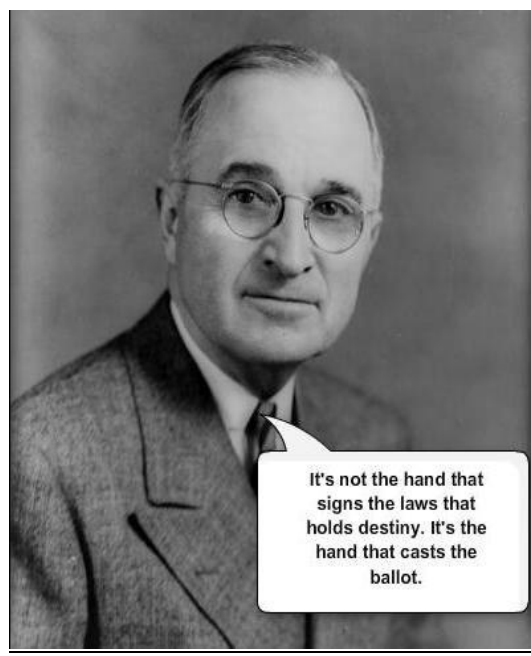
